The purpose of this application is to enable the current Walker's Point Board of Directors to make appropriate choices of Board Members for service to Walker's Point Youth & Family Center.

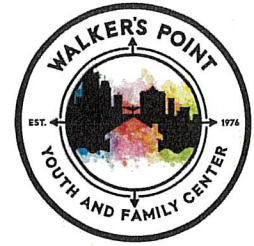

Walker's Point Youth & Family Center Board of Director Expectations:

- Support the Mission Statement of Walker's Point.
- Actively engage and recruit new board members, programming, funders, volunteers or donations.
- Work as a part of a cohesive team with common goals.
- Share his/her skills and expertise.
- Dedicate time to monthly Board Meetings & bi-monthly Committee meetings.
- Respect and support the majority decisions of the Board.
- Volunteer and assist in Walker's Point programs and activities, include fundraising efforts
- Participate actively in Board meetings, actions, fundraisers and public events.
- Have no more than three (3) consecutive unexcused absences from board or committee meetings.
- Represent all those whom this organization serves and not a particular geographic area or interest group.
- Remain aware of the activities that are planned and make yourself available to participate.
- Declare conflicts of interest as it pertains to your position on the Board and abstain from voting when appropriate.
- Do your best to ensure that Walker's Point Youth & Family Center is well-maintained, financially secure, growing and always operating in the best interest of the youth.
